Membership Application



1. I hereby apply for membership at the Eaton Country Club.
2. I understand and agree that if accepted as a member I will abide by all rules and regulations of the club and that I will be considered a member from year to year, January 1st through December 31st. Regardless of how I pay my dues, the whole year's dues and any applicable assessments during the year are still owed the club. If I wish to resign from the club I must submit a written resignation to the Board of Directors prior to or on January 31st of the year in which such resignation is intended to take effect. Members who have not resigned on or before such date shall be deemed to have renewed their membership and shall be obligated to pay the annual dues, assessments and taxes applicable to the type of membership held by them in the preceding year. Resignations received after January 31st shall be of no force and effect for that year and failure to pay the applicable dues, assessments and taxes shall result in termination of the membership in bad standing. By reason of the foregoing there shall be no refunds, partial or otherwise, of dues, assessments or taxes paid to any member failing to resign on or before January 31st of the year in which such resignation is intended to take effect.

REGULAR	\$1,070.00	Regular membership is defined solely for the purpose of classifying ECC membership as any two adults living in one household and any dependent children under twenty-one (21) years of age residing at the same address or in a continuous undergraduate college program. The members of the family are entitled to all club privileges with the right to one (1) vote on all Eaton Country Club matters.
SOCIAL	\$ 250.00	All club privileges are the same as the regular membership except limited to four 18 holes of golf per year, no guests, with payment of green fees.
YOUNG SINGLE/FAMILY	\$ 535.00	Includes memberships ages 19-29 years old and all club privileges as the regular memberships.
YOUNG SINGLE/FAMILY	\$ 750.00	Includes memberships ages 30-39 years old and all club privileges as the regular memberships.
STUDENT	\$ 240.75	Includes unmarried persons ages 18-22 years old enrolled as a full-time student Taking 12 credit hours. Limited privileges as to golf and beverage usage.
JUNIOR	\$ 240.75	Includes unmarried persons ages 15-17 years of age and enrolled as a high School student. Limited privileges as to golf and beverage usage.
NON-RESIDENT	\$ 396.31	Includes persons not a resident of Preble County or any adjacent county. Includes all club privileges.

No application for membership will be considered by the Board of Directors unless accompanied by the dues payable with the category described above.

Payment of Dues: Social, Young Single Adult/Family, Student, Junior and Non-resident must pay their annual dues in full by January 31st.

Regular membership: All members will be billed for the full amount of dues, assessments and taxes on January 1st of the ensuing year. Said amount will be due in full on or before January 31st. Or, in three installments: one-third by February 1st; one-third by April 1st; with the total balance due by June 30th.

Any member having an outstanding balance on or after June 30th shall be suspended and all club privileges revoked until payment in full is received. If full payment is not received by July 31st, the membership is terminated in bad standing and member shall not be eligible to again apply for membership prior to January 1st of the following calendar year.

All Regular, Social, and Young Single Adult/family memberships are subject to a minimum charge of \$120.00 every six months for food service. Beverages of any sort will NOT be included in your monthly restaurant minimums. Your monthly minimums will be for FOOD ONLY. Further, you will be billed on a 6-month basis and therefore, are expected to spend at least \$120 every six months to meet the minimum requirement.
